Required Public Disclosure for Waivers in Connection with the Medicare Shared Savings Program

The Centers for Medicare and Medicaid Services and the U.S. Department of Health and Human Services Office of Inspector General have provided certain waivers of federal fraud and abuse laws in connection with the operation of accountable care organizations that have entered into a participation agreement under the Medicare Shared Savings Program ("MSSP"). 80 Fed. Each Arrangement is identical in nature and set forth in a Care Collaboration Agreement between the ACO and each Home Health Provider, dated 4/9/2025. Under each Arrangement, the Home Health Provider will provide home health services (including wound care services) and care collaboration services for the ACO's assigned Medicare beneficiaries.

The Board of Directors authorized the application of the MSSP ACO Participation Waiver to the Arrangements on 7/9/2025, following a determination that the Arrangements support the goals of the ACO and are reasonably related to the purposes of the MSSP. Specifically, each Arrangement:

- Promotes accountability for quality, cost and overall care for a Medicare patient population;
- Manages and coordinates care for Medicare fee-for-service beneficiaries through an ACO;
- Encourages investment in infrastructure and redesigned care process for high quality and efficient service delivery; and
- Reduces costs to, or growth in expenditures of, the Medicare program.

The ACO will publicly disclose additional arrangements that qualify for MSSP ACO Participation Waiver as they are authorized by its Board of Directors on this website, in compliance with the public disclosure requirements.
